Instructions for Uploading the Essential Documents while filling the on line Centralized Admission Process (CAP) Application form for admission to LL.B.-3 Yrs. Academic Year -2019-2020 (Revised)

Candidates and Parents aspiring to seek admission to the Profession Full Time Degree Course in Law Leading to LL. B-3 Degree, are requested to neatly Scan the following documents & keep them ready for uploading on the Admission Portal from their Pen Drive / Desktop / Laptop, / Tablet while filling the on line CAP Application form.

- 1) Photograph Image: Colour Passport size photograph of the Candidate Size of photo file should be between 20KB to 50KB. The Image file should be saved in JPG or JPEG format.
- 2) Signature Image: Applicant has to Sign on white paper-piece with Black or Blue Pen. Signature image Size file should be between 10KB to 20KB. The Image file should be saved in JPG or JPEG format.
- 3) The documents listed in following Table should be saved in PDF format of Size up to 500KB for all documents
- 4) The Scanned Uploaded documents should be readable; should be scanned by using original documents. Candidate to upload the documents only after ensuring the visibility/clarity. If the uploaded documents are not readable then such documents will not be considered as valid. Candidate himself will be responsible for the wrong document uploading.
- 5) After filling complete on line application form, candidate should take the print out of CAP Application form. Also save the CAP Application form on their desk top or Lap top or in Pen Drive as it is required at the time of admission.
